**\*Notes for Graduate Tuition & Fees**

~Non-Resident students enrolled in the STB courses will be assessed at the resident rate when enrolled in only distance education courses (course sections starting with "X") during the term. Non-resident students enrolled in additional on-campus course(s) will be assessed the non-resident tuition rate for all courses in that term.

~Resident rate charged for 4 credits or less for Fall, Spring and Summer semesters.

~Most students will not pay the health fee for 0-4 credits. See exceptions.

~Books and supplies are additional out-of-pocket expenses. The average cost for books and supplies per semester is \$520. Costs typically range between \$320 to \$720 per semester, depending on a student's major and class load.

~Room and board are additional out-of-pocket expenses. The average cost per semester is \$3,861.
