Undergraduate Returnee/Reentry Instructions

The university requires nonimmigrant international undergraduates to complete the International Undergraduate Reentry Form after an absence of one semester or more (not including summers). The form should be completed and returned to 10 Enrollment Services well in advance of the opening of the term for which reentry is sought. Students who have previously attended lowa State only as nondegree undergraduates and who now seek to earn an undergraduate degree should complete an undergraduate application instead of this form. **Students** with bachelor's degrees who wish to take supporting graduate-level courses prior to applying for graduate degree admission should not complete this form, but should complete the nondegree graduate application for admission.

What happens with your reentry form?

If you want to change your curriculum

The Office of the Registrar will refer the reentry form to the college to which a student plans to enroll if the student desires to change curriculum.

GPA below 2.00

The Office of the Registrar will refer the reentry form to the college to which a student plans to enroll if the student has a previous lowa State University cumulative grade point average below 2.00, or since leaving lowa State, has completed additional college study with less than a 2.00 grade point average.

You will be contacted by email once you have been approved for reentry.

What to do after turning in reentry form?

On Have you attended another school since leaving lowa State?

Students who have attended another college or university since their last enrollment at lowa State must have official transcript(s) of all coursework attempted sent to the Office of Admissions, 100 Enrollment Services Center, lowa State University, Ames, IA 50011-2011. o Do you have an outstanding balance?
